- I. **Opening Prayer/Devotional:** Led by Deacon Jane.
- II. **Call to Order**
  - a. The meeting was called to order by Fr. Michael at 6:30pm.
- III. **Minutes of February 9<sup>th</sup>, 2012 Vestry Meeting (there was no meeting in March)**
  - a. Kyle Campbell motioned that the minutes from the February 9<sup>th</sup> Vestry meeting be accepted. Seconded by Le Roy Falk.
  - b. Minutes were accepted with one abstention (Jack Van Patten).
- IV. **Treasurer's Financial Report(s)**
  - a. Profit and Loss Budget Performance
    - i. #3003 \$897.95. Increased payment to lawn and garden for extra supplies and reimbursement.
    - ii. #3006 \$798.75 4<sup>th</sup> payment of a four payment plan
    - iii. #4011 \$254 includes two payments for workers compensation insurance. Right on track for budget.
    - iv. #4012 \$260.72 2<sup>nd</sup> payment for insurance. Employment liability insurance. It's also a four payment plan.
    - v. #5004 \$200.00 Music Ministry Team Leader to cover extra Sundays played in month. \$50 per service.
    - vi. #6003 \$1,184.85 for Father Michael's Insurance premiums
    - vii. #7001 \$87.94 for supplies
    - viii. #7002 \$149.95 for church supplies (Altar Guild)
    - ix. #7008 \$33.91 Sunshine program supplies.
    - x. \$2368 is transferred from Money Market account on a monthly basis.
  - b. Balance Sheet Operating Account
    - i. March 31<sup>st</sup>, 2012, we had \$2416.16 in Checking Account
    - ii. 8000 items (pass through accounts), April 1<sup>st</sup> all categories were zeroed out and checks were written to correct organization/people/accounts.
  - c. Balance Sheet Money Market
    - i. March 31<sup>st</sup>, 2012, we had \$30,517.74

- d. Balance Sheet Youth Programs
  - i. March 31<sup>st</sup>, 2012, we had \$805.86.
- e. Balance Sheet Building Fund
  - i. March 31<sup>st</sup> Balance is \$ 9, 292.83. \$3,024 was added based on giving.
- f. Month by Month Giving Analysis.
  - i. February and March. Comparing to last year, February was greater than last year. March this year was less. Father Michael pointed out that \$403.00 was added for parish retreat, and a fundraiser event by youth last year. Under Miscellaneous items, a gift of \$400 had been given to replace the Treasurer's computer last year. Specific gifts had been given last year that increased those items/amounts.
- g. Overall financial picture is positive.
- h. A question was asked about altar flowers. The altar flowers are a part of the budget and people also give money for altar flowers. Father Michael stated that there are three ways that monies come in for altar flowers: Easter Lilies, Christmas Poinsettias, or donating for a specific week. The specific question was whether the budgeted line item was relying on the donations, or if donations were extra. Father Michael stated donations offset the general budget. A line item was created to demonstrate how much money is utilized for flowers.
- i. Reports were received.

#### **V. Property Reports**

- a. Jr. Warden's Report: none
- b. Father Michael gave an update on the shed being broken into, where the pressure washer had been stolen. LeRoy Falk donated a power washer. The lock was replaced on the shed and an additional lock was added. There has been no further issues.
- c. Other Property Related Reports:
  - i. Lighting changes: Switching some of the exterior lighting or adding lighting. It was done. Inside the church, incandescent lighting has been gradually shifted over to florescent. Usage in the church had a dramatic decrease. Electric bill for PGE was almost \$75 less than the same period last year.
  - ii. Cross over entrance painted. Gold spray paint was used on it prior to Easter.
  - iii. Pulpit is in place in the Sanctuary.
- d. Property Issues that need to be addressed.
  - i. Trash is an ongoing battle, especially with the added shopping center next door and the high usage of the basketball court and playground. The lawn maintenance man generally picks up much of the trash in the areas he takes care of, although that is outside the scope of his responsibility.

#### **VI. Other Reports**

- a. Deacon's Report
  - i. Deacon Jane is pleased with the response for Hope Sanger. A list of needs was placed in the back of the church in addition to the "monthly" item in the bulletin.
  - ii. Deacon Jane will be teaching a Bible Study class on the "Life You Always Wanted". It will begin May 8<sup>th</sup>, held on Tuesday evenings at 6:30pm. It is a six week course.
- b. Youth Ministry Report: No new information.
- c. TEC vs. DSJ Lawsuit Updated: Tentative Trial Date: March 25<sup>th</sup>, 2013.
  - i. At the Chrism mass, some information was shared for others outside of the diocese suit.
  - ii. One parishes without a rector that is involved with the lawsuit. It is independently incorporated. Episcopal diocese contacted Sr. Warden at that congregation to talk about settlement to see if they were interested in settling. Bishop's position is

that he doesn't feel it would be in anyone's best interest to negotiate with the Episcopal Church for any kind of settlement. He has a problem as it gives them "ownership" of those properties. They are assuming the property is theirs.

- d. Stewardship Report
  - i. Father Michael met with David Duffy and a couple things are being pursued. He wants to have a program that reminds people of their stewardship responsibilities and remind people to use their share cards. Look at a large fundraiser (outside of the parish) to raise funds.
- e. Diocesan/Deanery, Ecumenical and Area Church News
  - i. Smaller churches in the diocese are really struggling. Bishop has been talking about "yoking" two parishes together to share a priest.
  - ii. Area churches. The pastor of the Grove has submitted his resignation. A retired pastor has taken up interim leadership.

## **VII. Old Business**

- a. Holy Week Services
  - i. Busy week. Services were held Wednesday through Sunday. Easter morning service, combined service, was a wonderful service. It would have been nice to see more at the Holy week days.
  - ii. Father Michael mentioned that he would love to see the congregation eventually move to a single service on Sunday morning. There are more things that can be done as a full congregation. Father Michael plans to have a single service on Pentecost and follow with a potluck picnic on the lawn between the church and the office building. Currently the only difference between the 8:00am and the 10:30am Sunday services are that one has music, the other does not.
    - 1. Ron suggested the possibility of having a single service once a month to help unify the two groups.
    - 2. Father Michael said he would want to survey the two groups first and will consider doing so in the fall.
- b. Other Old Business
  - i. Ron mentioned getting the lighting system on the basketball court working again. The people who play out there have destroyed the timer box. Ron has looked for motion sensors and other options.
    - 1. Father Michael mentioned that the basketball court has been a burden because of several problems associated with it, but that it is also a positive outreach. There is only one parishioner who plays.
