### I. Opening Prayer/Devotional

- a. Dcn. Jane Williams opened the meeting with a devotional from *Jesus Calling*

### II. Call to Order:

- a. The meeting was called to order by Fr. Michael at approximately 6:33m and a quorum was verified.

### III. Minutes of the March 10, 2014 Vestry Meeting:

- a. **LeRoy Falk** moved and **David Katzakian** seconded that the minutes from the March 10, 2014 Vestry Meeting be approved. The motion passed, with Debbie Bates abstaining.

- a. Jr. Warden:
  - i. Office Restroom Toilet has been repaired.
  - ii. Driveway Reflectors – no action taken, as yet.
  - iii. Lighted Sign at Kings Canyon & Burgan has been repaired. Broken fluorescent bulbs have been replaced as well as a transformer.
  - iv. Ron reported that the driveway sign on Burgan is deteriorating and that we may need to consider replacing it.
  - v. Other Issues:
- b. Sr. Warden:
  - i. No Loitering/Trespassing Signs: Bob Levinson reported that the signs have all been posted.
  - ii. Bp. Rivera Bld. Ramp & Deck Project: Bob reported that he has drafted a letter to be sent to Home Depot and Loew's soliciting donated materials needed for the project.
  - iii. Office Bld. Ramp & Deck: Bob reported that he will be staining and sealing the ramp and decking in the coming weeks.
- c. Fr. Michael:
  - i. There was some graffiti on our Mural. Fr. Michael was able to clean most of it.
  - ii. Fr. Michael reported continued issues with trash, spit on the sidewalks, cigarette butts, etc..
  - iii. Fr. Michael briefly reminded the vestry of the details of the agreement he previously negotiated with Sunnyside Marketplace and will lead a more in-depth discussion on this under New Business.
- d. Property Issues That Need to Be Addressed:
  - i. Fr. Michael reported that there are depressions around the Office Building foundation that need to be filled in with dirt. Ron will take care of this.
  - ii. Fr. Michael and Ron recently noticed that a second ceiling beam has also split at the bracket bolts. This beam is the beam on the Epistle side of the church closest to the main entrance and the split is by the outer wall. Ron will have an engineer look at it.

## **VI. Other Reports:**

- a. Deacon's Report:
  - i. Dcn. Jane reported that Lisa Hunt had been helping with getting the donated food for HOPE Sanger to their facilities while she recovered from her knee surgery.
  - ii. Anglican 4<sup>th</sup> Day is open to all. There will be an Altrea hosted by Saint Mary's this coming month.
- b. TEC vs. DSJ Lawsuit Update: We are awaiting a decision from Judge Black.
- c. Stewardship Committee Report:
  - i. Cruise Fundraiser: Ron will make color copies of the cruise flyer.
- d. Diocesan/Deanery, Ecumenical, and Area Church News:
  - i. Fr. Michael and Dcn. Jane will be attending the Diocesan Mass of Chrism this Thursday.

## **VII. Old Business:**

- a. Status of the new Fundraiser Bank Account: The new Fundraiser Bank Account has been opened at Union Bank.

## **VIII. New Business:**

- a. Fr. Michael gave a presentation to the vestry that focused on the meetings he has had with Sunnyside Marketplace from February to the present. Using diagram handouts Fr. Michael detailed the current foot traffic flow on and through our church property. Fr. Michael reported that after giving the issue much thought and prayer he made a proposal to Sunnyside

Marketplace that he believes will greatly reduce, if not eliminate, the vast majority of ongoing problems we have been experiencing on the church grounds. The proposal is for fencing to be installed that would enclose approximately 1 acre of land while at the same time keeping the church campus open and inviting. The cost of the fencing project is approximately \$8,000. Sunnyside Marketplace would pay for 100% of the cost of the fence project. The installer (Sanger Fence) could install the fence and gates during Holy Week. After discussion Fr. Michael asked if there was any objection from the vestry with going forward with this project. No objection was voiced with complete support from the vestry. Fr. Michel will authorize Sanger Fence to begin the fencing as soon as possible.
