I. Opening Prayer/Devotional

- a. Dcn. Jane opened with a reading from: I Corinthians 10 & related commentary.

II. Call to Order:

- a. The meeting was called to order by Fr. Michael at approximately 6:35 p.m., and a quorum was verified.

III. Minutes of the April 7, 2014 Vestry Meeting:

- a. Judy Wilson moved and Ron Hunt seconded that the minutes from the April 7, 2014 Vestry Meeting be approved. The motion was passed, with Adrienne Cantrell abstaining.

IV. Treasurer's Financial Report(s) as of April 30, 2014:

Through the first 3 months of the year, revenue is above budget by \$3,480, and expenses are under by \$1,222.

The Treasurer's reports were received.

Saint Mary's is organizing a Harvest Festival Bazaar fundraiser. The funds raised will be allocated between the Saint Mary's DHC Chapter and as gift back to the parish, in some form.

V. **Property Reports:**

- a. Jr. Warden: Ron reported on the following items:
 - Driveway reflectors/lamppost lights: Ron will calculate the cost for this project (cutting the driveway pavement to install the wiring, filling in the pavement from the cut, the cost of the lighting fixtures, etc.) and will make a proposal to the vestry for consideration at the June meeting.
 - Office buildings foundation/skirting: Still in process; should finish shortly.
 - Church beams: Ron has spoken with an engineer from FSU: Lloyd Krask. He will look at our beams and advise us on options for repairing the wood splitting that has occurred.
- b. Sr. Warden: With Bob absent, Fr. Michael gave the Vestry an update:
 - Deck refinish project – in progress.
- c. Fr. Michael:
 - Church, Hospitality Room, and Office Bld. have been pressure washed by Fr. Michael.
 - As a gift to the parish Fr. Michael has painted the entrance on the exterior of church and the north and east sides of the Hospitality Room. He still needs to paint the south and west sides of the Hospitality Room.
 - The Fencing has been installed and paid for. No cost to the parish. Further discussion under Old Business.
- d. New property issue:
 - Large dips/cracks in the parking lot are becoming a potential hazard. Ron & Fr. Michael are discussing remedies to the problem, as well as a solution to the winter flooding problem. In order to install the lamppost lights at the entrance to the parking lot Ron will need to rent a cement saw. If we move forward with that project it is his intention to also use the saw to cut a trench in the parking lot that would allow for the sump pump to be permanently installed year round. At that time he would also work on repairing the dips and cracks.

VI. **Other Reports:**

- a. Deacon's Report:
 - Update on her knee surgery, which has limited her mobility. She is very independent, and not usually one to ask for help. But, she asked Ron for help with replacing light bulbs and commented that you should remember to ask your church family for help when needed.
 - At the recent A4D Altea, Bishop Menees encouraged vestry members to attend Anglican 4th Day weekend: January 1-4, 2015.
- b. Stewardship Committee Report: No report
- c. Diocesan/Deanery, Ecumenical, and Area Church News:
 - Everyone should have received the Bishop's letter relative to the diocesan property lawsuit. Fr. Michael read the letter and discussed it at last Sunday's service. The Judge's preliminary decision was not in our favor, and the likelihood of it being "reconsidered" at this stage is low. Appeal is the most probable next step.
 - Bp. Eric Menees will be meeting with the Standing Committee and Diocesan Council on Saturday May 17 to discuss the Tentative and Proposed Statement of Decision. Bp. Eric is then holding an informational meeting at Saint James on Sunday May 18, where he invites all interested members of the diocese to attend. At both sessions, Bp. Eric will seek advice regarding decisions he must make as to the next steps we will or will not take in the property lawsuit.
 - Fr. Michael encouraged all Vestry members to attend the May 18 meeting, if they are able.

VII. Old Business:

- a. Follow-up on fencing – Fr. Michael confirmed that Sunnyside Marketplace has paid Sanger Fence.
- b. The result has been wonderful. Judy said she feels safer. The condition of the property is much improved, much cleaner.

VIII. New Business:

- a. Fr. Michael proposed fencing around the garbage dumpster; an 8' x 8' "L" shape to conceal the view of the dumpster from the street and the driveway. The cost would be \$600. Adrienne Cantrell moved and LeRoy Faulk seconded that we spend \$600 on the fencing. The motion was passed, unanimously.

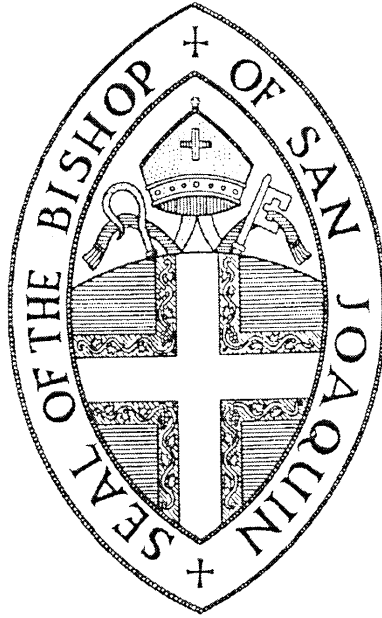
