I. Opening Prayer/Devotional

- a. A devotion about the working of the Holy Spirit was led by Dcn. Jane Williams.

II. Call to Order

- a. The meeting was called to order by Fr. Michael at 6:37 P.M.

III. Minutes of the September 12, 2013 Vestry Meeting

- a. Ron Hunt moved that the minutes from the September 12, Vestry Meeting be approved and Virginia Engel seconded it.
- b. The motion was passed.

V. Property Reports

- a. Bob Levinson reported that the carpeting repairs in the Bp. Rivera Building should be finished October 17.
- b. Ron Hunt reported that the safe has not yet been moved from the sacristy to the office building.
- c. Repainting of the parking lot stripes was discussed. Ron volunteered to ask the congregation to donate towards this project.
- d. Ron will pick up new handicapped parking signs and replace those in the parking lot that are sun faded.
- e. Father Michael will look for some inexpensive paint to repaint the exterior of the hospitality building.
- f. Debbie Bates mentioned the depressions in the cement where water gathers and people have slipped.
- g. Fr. Michael reported that the Propane Tank is only 30% full, not 50% full as previously thought. This is not enough fuel to last the winter (heat for the church and hospitality room). Ron is still working on pricing.

VI. Other Reports

- a. Deacon's Report: Christ Church holds a boutique at E.C.C.O..
- b. Youth Ministry Report: Andrew's Christian band, Before Kings, continues to use the practice space offered by St. Mary's.
- c. TEC vs. DSJ Lawsuit – We will present the Bishop with \$8,500 of the \$8,674 legal defense fund when he visits on Oct 13. We will keep the account open so as to continue receiving donations.
- d. Diocesan/Deanery, Ecumenical and Area Church News- Rev. Bruce Taylor of Christ Church in Lemoore will be leaving October 20. The church cannot sustain a full-time priest, so it will be utilizing supply clergy. Fr. Michael has also offered St. Mary's help in any way.
- e. The fundraising candles have arrived to be sold immediately.

- a. Pledge Drive Discussion: Fr. Michael recommended a Fall Pledge Drive. Bob Levinson will put out an initial letter with a pledge card, Fr. Michael will write a follow up letter, then the Vestry will do personal follow-ups.
- b. Pledge Cards need to be returned by Dec 1 and the Pledge Drive completed by Dec 12, so that the Rector, Treasurer, and Senior Warden will have the data to draft a proposed budget for the Vestry to consider and adopt at the January 9, 2014 meeting.
- c. The annual Parish meeting will take place on January 26th, 2014.
- d. There was discussion about moving the Vestry meeting to another day because two members have a conflict with the current second Thursday monthly date. We will revisit this discussion at the Oct Vestry Meeting.
- e. The Bishop asked that Saint Mary's DHC Chapter not have a checking account in their own name separate from other parish accounts. As a result of that request we have opened a new account at Union Bank in Saint Mary's name, designated for DHC (just like our Youth Account).
