- a. Bob L. reported that the carpet in the Bishop Rivera Building will continue to fray, so he will try to repair it using a special glue.
- b. The safe move from sacristy to office is still pending.
- c. Ron Hunt reported that the aluminum light poles stored on the west side of the property by the shed were vandalized and the small amount of copper wire in them was stolen.
- d. The parking lot stripes and handicapped symbols were repainted by Tim Lueth, Mike Engel, and Tom Metry.
- e. Ron H. picked up and replaced two handicapped signs.
- f. Fr. Michael reported that the propane tank holds 500 gallons and is 30% full. He will order an additional 200 gallons from Suburban so we will not run out this winter. They have agreed to sell us propane at \$0.60 over cost. The annual rental of the tank will be lowered to \$50.00.
- g. Since "foreign" trash has been being dumped into our dumpster, Bob L. and Ron H. went dumpster diving and found names and addresses, then called and asked them to stop dumping. Bob will put up a surveillance camera sign by the dumpster.
- h. A shopping card recovery company has been called and will come and pick up the shopping carts that have been left by the dumpster.
